

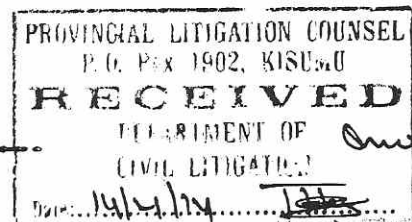
FURTHER TAKE NOTICE that should you fail to attend court on the said date and time, the matter shall nevertheless proceed to hearing and orders made regardless of your absence.

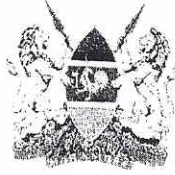
