In case of any costs incurred she'll pay it directly in my name.

Too, Mr. Ernest Mwanoyota is the representative and main-witness; He will represent the plaintiff in all the hearings. The next 3 month he is on a mission in his job as a sergeant of the police in Kenya.

Attorney Eric Garo Ondego from Kisumu has stopped communicating after he has got his payment in December 2017, so my client must also be able to get a new lawyer. In addition, he refused to hand over the affidavit from a German notary, certified by the German High-Court to the Environment & Lands Court in Kisumu. Till today he refuses to give back this important document to Mrs. Annette Opondo, our representative at the ground, nor deliver it to the Environment & Lands Court, which was his job in December 2017.

Under such conditions and without a lawyer at the ground we cannot recommend our customer to travel from Germany to Kisumu/Kenya.

In case only to hand over the affidavit that our case 48/2014 should not be discontinued nor dismissed. at the 10th of May, it should be possible, that our representative, Mrs. Annette Opondo can do this.

If the undersigned should have confused a hearing date, I politely ask for clarification.
