Please note that we have received the report from the Land Registrar Kisumu and now wish to bring to your kind attention the following:

- 1. That according to the land records held at the Kisumu Lands Registry, the above land parcels were transferred to Rudi Marquardt Electronic co. Limited on 6th December 2010.
- 2. That as per the transfer instruments the directors of the company were Rudolf Georg Marquardt pp/No.c61RKF9RT and Vallery Jimoi Khazalwa ID/No.25150565.
- 3. That on 24th August 2012 both properties were transferred to Vallery Jimoi Khazalwa a director of the company as per the land register.
- 4. That there are no transfer and consent to transfer documents in the parcel file in support of the entry on the land register.
- 5. That the land registrar purported to have signed the entry and issued the title to Vallery Jimoi Khazalwa as confirmed that the entry was fraudulently entered in the land register and that she had recorded a statement with Directorate of Criminal Investigations (DCI) and also testified in court on the same.
- 6. That on 24th October 2013 the said properties were again transferred to John Odindo Ogilo ID/No.1243267, Oscar Ogilo Odindo ID/No. 24935027 and Staline Yuaya Odindo ID/No.30242384 who are the current registered owners.

It is our opinion that Vellery Jimoi Khazalwa a director to Rudi Marquardt Electronic Co. limited fraudulently obtained registration and used a forged title to transfer the properties to herself and then to third parties thereby defrauding the company. In actual fact she had no good title to pass to the current proprietors. It's also our opinion that pursuant to Section 80(2) of the Land Registration Act, No.3 of 2012 only the court has the powers to nullify the title issued to John Odindo Ogilo ID/No.1243267, Oscar Ogilo Odindo ID/No. 24935027 and Staline Yuaya Odindo ID/No.30242384.

Section 80(2) provides:

The register shall not be rectified to affect the title of a proprietor who is in possession and had acquired the land, lease or charge for valuable consideration, unless the proprietor had knowledge of the omission, fraud or mistake or substantially contributed to it by any act, neglect or default.

I am informed that there is an ongoing suit in Court, it would be better that we wait for that outcome. Once again, I wish to retaliate that there are no documents at the Kisumu Land Registry relating to the transfer between the Company and Vallery Jimoi Khazalwa.

RE: REPORT ON PARCELS OF LAND KNOWN AS KONYA 4794 AND 5087

Your letter ref. KSM/A/17/VOL.XVI/129 dated 13th October, 2020 refers,

A complaint was raised by one MSSRS Rudi Marquardt Electronic Co. Limited on the above parcels of land.

The two parcels of land Konya 4794 and 5087 were registered to the complainant. Title deed no. 4794 was issued on the 9th December, 2010.

According to the transfer documents which were presented to the registry, the complainant is a Company Limited by shares whose directors were Pudolf Georg Marquardt and Vallery Jimoi Khalazwa.

The green cards show that on the 24th August 2012, Vallery Jimoi Khalazwa, the Co-director got herself registered as the sole proprietor of the two parcels of land.

FINDINGS:

There are no transfer documents in support of the said transaction though his name was entered on the green card on the 16th October, 2013. The said Vallery Jimoi Khazalwa transferred the two parcels of land to the current registered owners as per the green cards.

OBSERVATION:

From the forgoing, it seems that there is no proof of how the transfers were done from Rudi Marquardt Electronic Co. Ltd to Vallery Jimoi Khazalwa.
