RE: JUSTICE

Dear Mr. Hajji

*I'm Rudolf Marquardt from Germany and I personally visited your office last year.
I later send you a lady by the name Bilia Kilwahe with a power of attorney. I hope you can remember that.*

*I founded a company which bought a property with 2 parcels of lands and a house in Kisumu/Riat with a loan from a German bank, which is running till 2025!
In 2013 I was defrauded by several officials.*

Again, I seek your assistance because it was not easy to get the ruling from the hearing last year at the law court in Kisumu, case 542/2015. I've send now somebody to court to get a copy!

I'm shocked.

What happened there?

- **Why the DPP in Kisumu is not presenting to the court all the evidence?**
- **Not even 1 witness has been summoned to give evidence!**
- **The statements of the registrar are not correct and the investigation officers is aware?**
- **The registrar directed me to visit his office end of September 2013 to present him the "Original Title-Deeds" my representative Mr. Victor Joseph Njeru presented the certified copies which the registrar rejected, insisting on the originals which should be presented to him latest end of November 2013.
Nevertheless, by the time I presented the originals in November 2013 the Lands Registrar had already transferred the ownership using forged documents.**
- **The registrar should explain how he could use forged documents without sales contract and agreement of the owner.**
- **I can't understand why the DPP allows false statements when the evidence is in the files?**
- **With all the glaring evidence the DPP is silent on the Ruling?**

The DPP is aware that:

- **1. The investigation officers Simba Charo and Jeff Njeru accompanied us to the Registrar of Lands in November 2013 present the "Original Title-Deeds" which the Registrar made copies in the presence of 6 witnesses and kept.**

G.G. Gachihi himself:

Rudolf George Marquardt who is the majority shareholder of Rudi Marquardt Electronic Company Limited visited this office on 29th November, 2013 in presence of previous proprietor Alice Chepkemoi Ngeno and denied ever having transferred the properties to you. In addition he was in possession of the Original Title Deeds issued to him on 10th July, 2000 and 15th April, 2002 for both parcels.

At the request of Mr. Mwatata Munga, the personal assistant of the director of CID in Nairobi, the sealed and certified copies of the "Original Title-Deeds" were handed over to the investigation officer Shibeka with instructions to deliver them to the court in Kisumu.

"Now there is no need to bring the "Original Title-Deeds" again, so Mr. Munga.
